



Public Lecture of the Faculty of Law of UMA The Role of KPK RI in Handling Corruption Prevention and Eradication in Indonesia

The Faculty of Law, University of Medan Area (UMA) held a Public Lecture entitled "The Role of the Republic of Indonesia Corruption Eradication Commission in Handling Corruption Prevention and Eradication in Indonesia" on Friday (11/10/2019) at the Convention Hall of Campus I, Medan Area University.

Head of Corruption Eradication Commission (KPK) for 2019-2023, Lili Pintauli Siregar SH.MH. said the KPK commissioners in the future would prioritize corruption prevention rather than prosecution. One way is to create guidelines or guidelines that contain steps to prevent corruption that adopt concepts and good practices at national and international levels.



That was revealed by Lili when delivering a public lecture in front of hundreds of students from the Faculty of Law, University of Medan Area.

As for who attended the Public Lecture, the Dean of the Faculty of Law, UMA Dr. Rizkan Zulyadi SH.MH, accompanied by UMA Deputy Chancellor for Student Affairs Muazzul SH, M.Hum and Deputy Dean for Student Affairs Ridho Mubarak SH MH, lecturers and law faculty students. The speakers who were present were the elected KPK leaders Lili Pintauli Siregar SH MH.

According to Lili, this guide will later become a guideline for the head in implementing government policies. Thus there is no longer a regional head who does not know what he is doing once he is appointed as governor, regent or mayor, so far it often happens that the regional head does not know what he will do when he is given the mandate to become a regional head. By having a guide, the regional head will know the main tasks and functions, which old regional head program can be continued, and which regional deputy head's duties. Therefore there will be no confusion which hinders development, "Lili said in the public lecture.

In the context of preventing corruption, said Lili, the KPK will also increase the quantity and competence of the executor of the duties of prevention and supervision. He hoped that all parties would be actively involved in assisting the government and the private sector in building a good corporate, good governance and anti-corruption system. No less important is building an anti-corruption

education curriculum at every level of education in the community and in every training in the ASN and Apgakum environment as public servants, "said Lili.



Then increase cooperation and coordination with BPK, BPKP, the Government Internal Supervisory Apparatus or Internal Supervisory (APIP) in order to maximize the oversight function and prevent corruption. The KPK will also encourage the private sector to play an active role in preventing corruption in the corporate environment, "said the former assistant public defender of the Medan Legal Aid Institute (LBH).

UMA Deputy Chancellor for Student Affairs Muazzul in his remarks hoped that Lili as the proud daughter of North Sumatra was able to carry out the tasks of eradicating corruption indiscriminately. He appreciated the steps of Lili Pintauli who met and exchanged relations with a number of North Sumatran leaders and community leaders before being installed in December as a KPK commissioner. For steps to prevent corruption, there must be dialogue and friendship. But if there is something wrong between the leader of North Sumatra and national figures, just brush, "hopes Muazzul.

Previously, the Dean of the Faculty of Law UMA Rizkan Zulyadi said, the public lecture was an extraordinary opportunity for students. The reason is, after being officially inaugurated later as KPK deputy chairman, Lili Pintauli Siregar will be narrow when it comes to campus. We hope that this public lecture featuring the best sons and daughters of North Sumatra and the nation will be a motivation for UMA Law Faculty students to study harder, "said Rizkan.
