



University Of Medan Area Are Ready To Face The New Normal

The University of Medan Area stipulates the New Normal Health Protocol which must be obeyed by all campus residents while in the UMA Campus environment, namely:



1. Everyone is required to check the body temperature by the security guard at the entrance gate, before entering the UMA Campus environment.
2. Everyone must use the mask properly according to health rules.
3. Everyone must wash their hands in the space provided or use a hand sanitizer before entering the room.
4. Everyone is required to maintain a distance (physical distancing) while in the campus environment.
5. Avoiding crowds (more than five people) while in the campus environment.

6. Everyone is not allowed to attend on campus and is allowed to rest at home, if you experience Covid-19 symptoms.
7. Everyone must take an active role in maintaining hygiene and health while in the UMA Campus environment.



Medan Area University has prepared Infrastructure for the implementation of the New Normal Health Protocol, in the form of:

- a. Providing hand washing facilities in all campus buildings.
- b. Provides hand sanitizer facilities at every room entrance throughout the campus building.
- c. Spray disinfectant in all rooms in each building, before and after use



d. Installing appeals billboards placed in strategic locations, containing: 1) maintaining cleanliness, 2) the obligation to use masks, 3) e. applying social distancing, 4) diligently washing hands in the space provided, 5) wearing gloves, specifically for participants f. practicum, 6) throwing trash in its place, and 7) maintaining campus order.

f. Provide special masks for guests.

g. Installing Warning Board "AREA MANDATORY TO USE A MASK AND WASHER" in a strategic location in the UMA.

Impose sanctions for those who violate health protocols.



In addition, Medan Area University has issued regulations and regulations that guarantee the implementation of the New Normal Health Protocol in the UMA Campus Environment, in the form of:

- a. Issued the chancellor's decision letter for the Covid Supervisory Task Force at the University and Faculty level.
- b. Setting new security standards.
- c. Setting new health standards for lecturers and staff.
- d. Set new information and communication system standards.
- e. Establish new monitoring and evaluation standards.
- f. Set new schedule and workday standards for employees and administrative staff.
- g. Carry out socialization of all policies and implementation of new standards through online presentations in an ongoing, directed, comprehensive, and measurable manner to all academics and campus residents.

h. Publish the Health Protocol for implementation:

Administrative Services.

Class Activity

Guest Services.



- i. Implement a blended learning lecture system starting in the Odd Semester TA. 2020/2021.
- j. Publish online education and service applications, to reduce campus gathering activities.
- k. Publish online service applications and administrative processes to improve paperless application.
- e. Publish the application system for payment of tuition fees and other costs to reduce the frequency of student attendance on campus.
